NCL Summer Games Competition – Terms and Conditions

Subject to these terms and conditions; if you correctly answer the question and you submit the information required to allow us to process your entry by 5pm (GMT) on 24th May 2018 you will be entered into a draw for a chance to participate and represent Campus Living Villages at the NCL Summer Games.

The NCL Summer Games will be held in Istanbul on 29th June 2018 until 1st July 2018 and you will be required to travel between 28th June 2018 until 2nd July 2018 from/to any London airport or Manchester airport.

Entry into this competition is deemed full and unconditional acceptance of these terms and conditions.

- 1. The Promoter of this competition is Campus Living Villages UK Limited (Company No: 06604874) of 6th Floor, One London Wall, London, EC2Y 5EB.
- 2. The competition is open to all current residents in any CLV Village who:
 - a. are over 18;
 - b. are resident in the UK;
 - c. have received confirmation from the Promoter that they have submitted a valid booking for the academic year 2018/2019 at one of our Villages; and
 - d. have no record of being in arrears or in breach of any terms of the accommodation agreement in relation to any booking with us past or present ('Eligible Applicant').

Applicants will no longer be considered Eligible Applicants if their booking for the academic year 2018/2019 is cancelled or if any of the requirements in this clause cease to apply.

- 3. To complete their entry Eligible Applicants must answer the question correctly and nominate four (4) friends who would also meet the criteria of an Eligible Applicant ('Companions'). Eligible Applicants must obtain those friends' consent and show them these terms and conditions before submitting their entry. Entries will be invalid if it appears any Companions have been named who did not agree to it.
- 4. In entering the competition, applicants confirm that they and their Companions meet the criteria of Eligible Applicants.
- 5. Only one entry per Eligible Applicant.
- 6. All entries must be made directly by the Eligible Applicant. Using a false name will result in disqualification.
- 7. The competition will be open between 9th May 2018 at 12pm and 24th May 2018 at 5pm (GMT). All competition entries received after this will be invalid.
- 8. Winning the prize is contingent upon fulfilling all requirements set out in these terms and conditions.
- 9. The prize is a chance to participate and represent Campus Living Villages at the NCL Summer Games in Istanbul on 29th June 2018 until 1st July 2018. The prize includes:
 - airport transfers;
 - flights
 - full insurance cover provided by Endsleigh (to cover activity holidays and includes risk
 of illness or injury, subject to any excess and restrictions full details available here);
 - accommodation:
 - main meals (breakfast, lunch and dinner including all non-alcoholic drinks);
 - · transport to and from the NCL Summer Games; and
 - £100 spending money per person.

The Prize does not include costs associated with non-competition activities, snacks and drinks outside of main meals or other personal expenses.

10. There is one prize available.

- 11. The prize is non-negotiable, non-transferable and is not redeemable for cash or other goods or prizes.
- 12. One winner will be randomly selected from among all Eligible Applicants who have submitted a correct answer to the question. The draw will take place on 25th May 2018, 10am (GMT).
- 13. The Winner will be announced on the Promoter's social media on 25th May 2018 and the Promoter will contact the Winner using the details provided on entry as soon as reasonably practicable.
- 14. The Promoter will make all reasonable efforts to contact the Winner. If the Winner cannot be contacted, he/she and all of their Companions are not available to take up the prize in accordance with clause 15 or if the Promoter reasonably considers that any other conditions of these terms and conditions have not been met, the Promoter reserves the right to offer the prize to the next Eligible Applicant selected from the correct entries that were received before 5pm (GMT) on 1 June 2018.
- 15. The Winner and their Companions will be required to travel between 29th June 2018 and 1st July 2018 and take part in the Summer Games as representatives of the Promoter between those dates.
- 16. The Winner and their Companions will be required to show the Promoter that they have valid passports with at least six months validity within 14 days of being notified that they are the Winner or have been invited to join the Winner, as applicable.
- 17. The Winner must ensure that they and their Companions have the correct travel documentation (including a valid passport with at least six months validity and travel insurance), obtain the relevant Visas if necessary and meet travel health requirements. Such documentation is at the sole expense of the Winner and their Companions as appropriate. Failure of the Winner or any of their Companions to be granted a Visa, to provide evidence to the Promoter that they meet travel health requirements and/or have the necessary travel documentation by a date stipulated by the Promoter, will result in the Winner forfeiting the prize.
- 18. The Winner and their Companions will be accompanied by an employee of the Promoter and will be expected to follow that employee's instructions.
- 19. The Winner agrees, and warrants that their Companions will agree, not to discredit, denigrate or bring the Promoter or its brand, products and services or that of its business partners into disrepute.
- 20. The terms and conditions of any third party supplier will also apply to the prize where applicable.
- 21. The Winner agrees to the use of their name and home town/city to be used by the Promoter and its associated companies for post-event publicity purposes (including but not limited to publishing on the Promoter's website and social media), and will co-operate with any other reasonable requests by the Promoter relating to any publicity. The Winner agrees, and confirms that their Companions have agreed, to allow the Promoter to use their name and likeness for advertising and publicity purposes without additional remuneration.

Any personal data relating to Applicants or their Companions will be used solely in accordance with UK data protection legislation and will not be disclosed to a third party without the individual's prior consent. Please see the Promoter's Privacy Policy for further details. Data relating to Applicants will be retained by the Promoter until 2nd July to ensure that the prize can be fulfilled.
- 23. The Promoter may refuse or disqualify any entry (including winning entries) if the applicant concerned acts in a way towards the Promoter which the Promoter reasonably considers to be inappropriate, unlawful or offensive. If the Winner is disqualified in accordance with this clause

the Promoter reserves the right to award the prize to the next Eligible Applicant selected from the correct entries that were received before 5pm (GMT) on 24th May 2018.

These terms and conditions, and any issues or disputes which may arise out of or in connection with them (whether such disputes or issues are contractual or non-contractual in nature, such as claims in tort, for breach of statute or regulation or otherwise), shall be governed by and construed in accordance with English law. Applicants hereby irrevocably submit to the exclusive jurisdiction of the English courts to settle any such dispute or issue.
